Article I. Aim

The University stipulates the regulations governing the selection of recipients of the “Outstanding Youth Awards” (“the Awards” hereafter) with the aim to encourage students who have passions towards life, communication ability, and Christ-like spirit of serving and leadership, so as to serve society and mankind.

Article II. Selection Criteria

1. Eligible candidates and conditions: All the students who have enrolled and completed at least a year of study in one of the academic systems at the University. An applicant should have a minimum grade point average of 75 or above, no record of minor demerit or above, and continuously demonstrate one of the following achievements:
 - A. Outstanding academic performance, solid research achievements, or discoveries.
 - B. Participating enthusiastically in volunteer and charitable services with outstanding achievements.
 - C. Outstanding achievements in leadership, served as the cadre in class or students clubs with outstanding achievements.
 - D. Other outstanding achievements which are to be recognized as a model for all students at the University.

2. Methods of Application

By recommendation or self-recommendation: Eligible candidates can be recommended by the University's administrative units, departments, classes, and student organizations or individuals. Detailed accounts of a candidate's relevant information should be enclosed and submitted to the Extracurricular Activities Section before the designated date.

3 Methods of Assessment

- A. Initial screening of the written documents will be conducted by the Extracurricular Activities Section.
- B. The review panel includes a representative from the Office of Students Affairs, a representative from the Division of Continuing Education, a representative from faculty members and staff from every department, and three student representatives. The panel will conduct the secondary review, and the maximum number of awardees is up to 15.

Article III Award

The awardees would be announced by the University president after ratification. A scholarship of NT\$ 5,000 is provided for each awardee, and each awardee will receive a certificate of merit and public commendation by the University.

Article IV: Time for Application

Please refer to the announcement made by the Extracurricular Activities Section every October.

Article V. These regulations shall be implemented after the approval of the Student Affairs Meeting and ratified by the University president. The same shall apply in the event of any amendments.
